

Private Rented Home Green Deal Project Assessment Cashback Application Form

To coincide with the Green Deal Launch, UK Landlord Accreditation Partnership (UKLAP) are offering £50 assessment cashback per property for landlords in London and the South East region who undertake Green Deal assessment s in rented properties over the next few weeks (the scheme will end at the latest on 27 March).

The scheme is open to any landlord of a rented property in Greater London, Essex, Kent, Hertfordshire, Buckinghamshire, Berkshire, West Sussex, East Sussex, Surrey, Hampshire and Isle of Wight.

For landlords who undertake UKLAP Green Deal training, to run in February, £75 assessment cashback is available.

London Borough of Camden is the facilitator of the UK Landlord Accreditation Partnership and is receiving support from the DECC Local Authority Green Deal Pioneer Places Fund for this project.

Submitting your Application and claiming your Cashback

Submitting your application

Any landlord planning or undertaking a Green Deal assessment in the qualifying area (see above) before the 22 March 2013 is welcome to submit an application for the cash back scheme.

Processing your application

Once your application has been received, we will advise if your application has been successful within 5 working days. This will depend on:

- Level of demand for the funding which we are allocating on a first-come-first-served basis
- Number of properties you are putting forward for assessment cashback

Once your application has been approved, you should have your Green Deal Assessment carried out by an accredited Green Deal Assessor (http://www.greendealorb.co.uk/assessors/assessor-search). This should be completed within three weeks (15 working days) of your application being approved or by 22 March 2013 – whichever is the sooner.

Claiming your cashback

Once the assessment has been completed, simply email the Report Reference Number from the Energy Performance Certificate that forms part of your Green Deal Report to LLAS.GreenDeal@camden.gov.uk and we will then process your cash-back payment. This must be received by the 22nd March 2013.

Data protection

The London Borough of Camden is collecting your details for the purpose of providing you with funding for carrying out a Green Deal Assessment. We will retain your details in order to monitor the effectiveness of this funding programme and to inform the Department of Energy and Climate Change (the funder of this project) of how monies have been allocated.
