What is the Two Year Old Integrated Review?

The Two Year Old Integrated Review is a valuable opportunity to reflect on how your child is progressing and how to support their future development. You know your child best and the information you share is very important. Your local Health Visiting Team and early years practitioners (childcare setting staff, childminder or Children Centre staff) will work together with you to gain a clear picture of your child's progress and identify any needs.

What is the purpose of the review?

The joint discussion is an opportunity to look at your child's progress, strengths and anything needed to support your child's health, wellbeing, learning and behaviour.

It is a chance for you to ask any questions about your child.

What will happen?

When your child is between 24 - 30 months you will receive a letter from your Health Visiting Team inviting you to attend the review with your child.

Along with this letter you will receive an Ages and Stages Questionnaire (ASQ) to complete and bring to the review meeting. Your local Children's Centre or early years setting can advise you if needed. The questionnaire is an opportunity to find out how your child carries out activities in different developmental areas.

If your child attends an early years setting or Children's Centre the early years practitioner will discuss your child's development with you and complete a summary of your child's learning and development, before the review.

At the review session there will be a range of play activities for you and your child to enjoy.

You will also be able to speak to the Health Visiting Team about how to keep your child and family healthy.

Where will this take place and who will be involved?

If your child attends an early years setting the review should take place there. If not, you will be invited to a review at a Children's Centre.

The review will involve you, your child, a member of the Health Visiting Team and an early years practitioner. Other professionals who may be involved in your child's development and learning can be invited if you feel it is appropriate.

Your views and any concerns you may have about your child are the most important part of the review.

If your child attends an early years setting the Key person will provide detailed knowledge of how your child is learning and developing, based on day-to-day observation in their early years setting.

The Health Visiting Team will talk to you about your child's health and development.

What happens after the review?

You will keep the copy of the questionnaire (ASQ) and Two Year Old Integrated Review form to share with other professionals if you wish.

The health practitioner and early years practitioner will also have a summary for their records and help plan for the child. The health visiting team will write about the review in your child's Red Book.
