## Women's Environmental Network give case study presentation to Partnership.

Key points:

26 projects focused on Tower Hamlets food system.

- Closed loop system site in R-Urban Poplar
- Compost toilet in Mile End Community Garden
- Culturally appropriate and subsidized veg from Folx Farm, Sussex
- Grow-cook sessions for SEN class at Bowden Primary
- Composting capacity on St George's Estate
- Food and Land Justice Centre at Kinglsey Hall
- Plastic free Poplar
- Herb learning for POC by Misery Medicine
- Providence Row growing training for people with experience of homelessness.
- 3 food co-operatives

## WEN are offering:

- Visits to Just FACT projects/join us on knowledge exchange trips to other parts of the country.
- Support to co-design opportunities to collaborate with Tower Hamlets communities to shape policy/strategy.
- Support to include residents in the work of the climate partnership.
- Participatory grant making.

## Greening, growing and biodiversity sub-group (Tower Habitats).

Updates given by subgroup chair John Archer (Tower Hamlets Council)

- next meeting is on May 23.
- Local Biodiversity Action Plan draft for May meeting
- A couple of good news stories from Rewild London Fund Swans are using the Wapping Canal raft habitats that were constructed in February.
- JA asks that the Women's Environmental Network (WEN) be represented on the Subgroup and will contact ZM from WEN.
- JA showcases other interesting projects in the borough that require further research: WildE3, Urban Growth/Clarion Housing, Greening across Lincoln Estate, Poplar HARCA/FoTHCP. Linc the SINCs

## Workshop Activity - Climate Conversations (Run by SB)

## CP Members were organized into breakout groups to discuss the following:

- Talk about a recent climate related project in your organization.
- How is your organization contributing to the wider remit of transitioning towards net zero?

## **Projects and initiatives Members discussed:**

- QMUL implementing a coordinated "shut down" approach to rooms that are manually managed i.e. stickers/signs with reminders to switch off and power down.
- Talked through how complex it can be to enact projects with a PFI as legal variation to contract is required, which can prove expensive and require a business case.
- Circular Economy Tech Takeback recycled/refurbishment project (phones/laptops etc) donations through ELBA.
- Heart of the City Canary Wharf Group Supply chain emissions training program, supporting on understanding emissions and development of net zero
- QMUL Addressing building emissions especially emissions from gas heating systems. Looking at putting key buildings into "hibernation" stage to show savings.
- Tower Hamlets Council E cargo bikes for businesses 600km distance covered, leading to emissions savings.
- Green Theatres Royal London changing the uses of theatre ventilation that saves energy, engaging clinicians, creating an operating procedure.
- Friends of Meath Gardens have created habitats and planted lots of trees in Meath Gardens over the last few years, with an active membership of 200 volunteers.
- Menu flipping at New City College
- Wen's Climate Sisters project which isn't about reducing carbon emissions but about understanding everyday climate issues.
- We talked about our organisations and how we are attempting to reduce our gas emissions and how we are looking at our ventilation and how this can be turned off in areas.
- Efficiency measures across buildings managed (insulation, lights etc.)
- Poplar HARCA's Community Carbon Champions resident group educating ourselves & the local community about climate change in a fun & practical way.
- QMUL addressing direct and indirect emissions. Looking at our realm of influence, how can we motivate behaviour change beyond our organisation.
- Tower Hamlets Council identifying locations for sustainable micro-logistics sites through planning system.
- ICB our main function is to convene and connect, so we oversee system wide networks covering medicines, travel, and estates.

ZM – highlights that community-based food solutions are important but do not hold large emissions currently due to the lack of power being held in these spaces.

### Climate Communications (All)

- How can we use Tower Hamlets good news stories to inspire change?

ZM – asks for there to be a space for good news stories to be stored to reduce research fatigue. Could be focused on community-based solution.

JM – powerful if a business sees another business doing an action. Fundamental to change in the borough. Good news stories need to be shared widely. Important for climate partnership members

RB – discussed the availability of newsletters and networks within the council. Our East End – Quarterly publication – corporate ongoing strand we could attach the good news stories to. There is

also potential to utilise the Housing Forum. Identify local community champions from the area of Tower Hamlets that can promote good news stories.

CC – stated that Canary Wharf Group owns interactive boards around Canary Wharf which could display climate activities in the borough. The displays would need to be short and engaging for passers-by. Contact Canary Wharf Group or attend the Innovation and Leadership subgroup to find out more how the partnership could utilise them.
