**New Homes at Tent Street - Invitation to Development Update Event**  
**Thursday 19<sup>th</sup> January 2017, 3pm - 7pm**

As you may be aware the Council carried out a number of consultation events in July/August 2016, to show residents its proposals to develop new affordable homes on a piece of under used land at the western end of Tent Street. Since then, the designs have changed significantly and we would like to hear your views on the revised proposal.

At the most recent consultation event held on 22nd August 2016, the designs that were shown were based upon access to the new development being through both Tent St and Granary Road, requiring the removal of the wall at the northern end of Granary Rd.

Having heard resident's views over the summer at the three events, as well as additional feedback through a large number of written representations, the Council reviewed the designs, to try to accommodate residents' concerns about the removal of the wall. This has required some significant changes to the design of the development; however the new proposals no longer require the removal of the wall at Granary Road or any form of access through this route.

The Council would therefore like to invite you to an update event for the scheme, to provide further details on parking proposals, to show you the new scheme designs, and discuss them with you, before they are submitted to the Local Planning Authority for consideration.

The event will be held on **Thursday 19<sup>th</sup> January 2017, between 3pm - 7pm, at the Collingwood Community Hall, Collingwood Street, Bethnal Green, E1 5PY.**

The event will be attended by Council Officers along with the project architects who will be available to answer any questions which you may have.
