Re: Lister House and Treves House – Next Steps


Firstly I would like to thank residents for taking time to meet with me on the evening of the 18th July 2017 to discuss how we can take forward together the building condition issues at Lister House and Treves House.

At the meeting on Tuesday night I promised the following –

- That there will be no reports on proposals for Lister and/or Treves House to my Cabinet until residents have been fully consulted on them. For the avoidance of doubt, this includes the proposals which you may have previously heard were being considered.
- That a working group will be established with residents to explore the refurbishment costs and any redevelopment options in detail. I have asked officers to liaise with the TRA to establish this group as soon as possible.
- That the council will be transparent in its discussions with residents and will make available records of works undertaken to both Lister and Treves House over the last few years.
- A document will be issued shortly to address some of the frequently asked questions that residents have raised so far.

I stated at the meeting and in my previous correspondence to you that it is important that Council understands the condition issues of both blocks and sets out clear plans as to how they intend to address them. I believe the best way to secure the right outcome for the residents of both blocks is to move forward in an open manner and to ensure we address the matter together.
