The Tower Hamlets Homeseekers Open Day took place on Saturday 23rd February 2013 at Albert Jacobs House, 62 Roman Road, London E2 0PG.

There were 256 people who signed in at reception, but many had also arrived with their partner and/or family, so there were actually over 500 people at the event.


A Survey was conducted at the Open day and showed that 91% of people who attended were Tower Hamlets residents and 61% had lived in Tower Hamlets for 8 years or longer.

93% of people who took part in the survey found the information at the Open day easy to understand.






The Housing Options Services are still improving their waiting times.

£90m of Improvement Money for London's Private Rented Homes

Major opportunity for landlords, and for London to get its share of energy suppliers' money

New analysis by the London Landlord Accreditation Scheme shows that privately rented homes in London should benefit from at least £90m of improvement grants from energy companies over the next two years, but it's up to London's landlords to claim their share of the money. In the past, London's homes have missed out on this investment.
