



Locksley Site D (Salmon Lane) – New Build Proposals Update August 2016

The Council have embarked on a new build programme to provide additional affordable housing to relieve over-crowding, improve the quality of accommodation and the lives of tenants, and to assist in the management of anti-social behaviour and crime. The proposals to build on Locksley Estate Land at Salmon Lane and adjacent to 1-12 Parnham Street is part of a wider programme being undertaken by Tower Hamlets Council

The proposed development will provide 20 homes with a mix of 1, 2, 3 and 4 bed room flats for affordable rent and will include wheelchair accessible flats.

The Council have been consulting with locals resident on the proposals since August 2015, seven consultation events took place which concluded in May 2016. Following the final consultation event on 09th May, we would like to inform you that the planning application has now been submitted to the Tower Hamlets Planning Authority.
