#### **Lord Victor Adebowale**

Lord Victor Adebowale is the Chief Executive of the social care enterprise Turning Point and was one of the first to become a People's Peer. In 2000 he received the CBE in the New Year's Honour List for services to the New Deal, the unemployed, and homeless young people. In 2009 he was listed as one of the 25 most influential people in housing policy over the past 25 years by the housing professionals magazine *Inside Housing*.

Turning Point is a care organisation providing services for people with complex needs, including those affected by drug and alcohol misuse, mental health problems and those with a learning disability. In addition to providing direct services, Turning Point also campaigns nationally on behalf of those with social care needs.

#### **Andrea Baker**

Andrea is Director of Housing at Poplar HARCA. She joined Poplar HARCA in 2008. She has also worked for Richmond Housing Partnership, Swan Housing Group, Tower Hamlets Council and Southwark Council.

She has worked in housing for over 20 years, 16 of them Tower Hamlets. In her 13 years working for Tower Hamlets Council she was responsible for, amongst other things, putting together the Common Housing Register and Choice Based Lettings scheme.

Andrea's team at HARCA is responsible for delivering housing services including income, ASB, lettings, tenancy and leasehold management and customer services. In the last year there has been a 19% increase in resident satisfaction which follows a major restructure last year. The new housing roles focus on a model of management based on building relationships with residents and early intervention.

Andrea also has a corporate portfolio which includes Strategy, Communications and Organisational Development. She is a Trustee for Neighbours in Poplar and on the Boards of Social Landlords Crime and Nuisance Group, Capital Conflict Management and Resolution for Life all not-for-profit organisations whose missions are very close to her heart.

Poplar HARCA was created by Tower Hamlets Council as a means to raise muchneeded funding to regenerate one of the most deprived areas of the country. Our mission is to make our area a place where people choose to live, work and enjoy life.

In 14 years we have established an organisation that is internationally-recognised and a sector leader in Community Regeneration and we are investing over £1billion to realise our mission. We now own and manage almost 9,000 homes in four square miles. Over one-third of our award-winning staff lives locally.

With partners and local residents we facilitate community projects, initiatives and social enterprises from Community Hubs on our 12 estates.

We have not achieved so much alone and work closely and productively with key statutory and third sector agencies – not least of which is the Council which remains one of our most important stakeholders.

Our Board has a resident majority. Our residents drive us and we have an award-winning empowerment and governance structure which ensures that they have a direct and meaningful say in the decisions taken. We have a Youth Empowerment Board which secures resident-driven governance into the future.

#### Alan Benson

AlanBenson has been Head of Housing at the Greater London Authority since October 2004. Alan has been in local government since 1988, working mainly in housing and corporate strategy. Immediately prior to joining the GLA in September 2003, he was responsible for housing strategy and performance management at the London Borough of Hammersmith & Fulham.

#### **Duncan Bowie**

Sheron Carter was appointed as Chief Executive of Gateway Housing Association in May 2011 following the retirement of Adrian Greenwood who led the Association for 35 years.

Sheron's housing career dates back to 1984 when shewas appointed as a resettlement worker with Sandwell Homelessness & Resettlement Project. Sheron went on to work for 3 Birmingham based housing associations as a housing officer and senior housing officer before moving to London in 1992 to set up and lead a homelessness charity.

Sheron has since held several senior management positions with London based housing associations including Head of Community Development at Ujima Housing Association, Head of Regeneration at Genesis Housing Group and Chief Executive at Arhag Housing Association. Sheron has also worked intermittently as a housing consultant and assignments included undertaking the Equality Impact Assessment of Tower Hamlets Choice Based Lettings Scheme and setting up Tower Hamlets Homelessness Partnership.

## **Owen Whalley**

Having graduated with a degree in Town and Country Planning in the late 70's Owen headed straight for the dynamism and the challenges that town planning in London did and still represents and cut his teeth as an Assistant Planner with the London Borough of Lambeth.

He obtained wide experience of all aspects of the planning service and after 11 years moved north of the river to join Tower Hamlets Council where some 24 years later he is now the Service Head of Planning and Building Control. In this role, Owen is responsible managing an integrated service focussed on improving the lives of all those living and working in the Borough. The service is in the main statutory and it impacts significantly and constantly on the whole of the Borough.

In managing development pressures, it delivers new and affordable housing, facilitates and supports economic growth and regeneration, identifies and facilitates the provision of new social infrastructure including health care, public transport, education, leisure facilities and open space. Owen is also responsible for setting the direction and framework for progressing some of the largest private sector development schemes in the country, the preparation of development frameworks, briefs and masterplans, and steering the delivery of the borough's Local Development Framework documents.

Despite working for the same organisation for over 24 years, Owen finds the increasing pressure for development and the continuing imperative to address housing need and employment opportunities as challenging today as in the 1980's. The borough has been transformed over this period but much remains to be achieved.

Once a keen long distance runner, pressures of work has reduced Owen's ability to maintain the necessary training regime and so now in his spare time he is a rather more passive but no less keen follower of sport including football, rugby union and cycling. Living on the Kent/Surrey borders, Owen is also often tempted into the countryside in an effort to find a remote public house serving a decent pint of beer.
