# Community Infrastructure Levy (CIL): Collection and Expenditure Report For Financial Year 2016/17

#### 1.0 Introduction

- 1.1 This report sets out the amount of local CIL collected and spent in the financial year 2016/17, in accordance with the requirements set out in section 62 of the CIL Regulations 2010 (as amended).
- 1.2 CIL is a pound per square metre levy charged on most new development granted planning permission. Its purpose is to contribute some funding for the provision of new infrastructure needed to support development. The Council adopted its own local CIL in April 2015 and has been collecting this CIL since this time for developments granted planning permission after 1<sup>st</sup> April 2015.

### 2.0 Income and Expenditure Information

- 2.1 Please see table 1 below which sets out the Council's position with regard to the reporting requirements set out in Regulation 62 of the CIL Regulations:
- 2.2 At Cabinet on 6<sup>th</sup> December 2016 it was agreed that the approach to be taken in Tower Hamlets is that 25% of local CIL receipts should be allocated as the CIL Neighbourhood Portion / 'Local Infrastructure Fund' across the whole borough. Four area boundaries were also reported and it was agreed that Neighbourhood Portion should be defined as 'Local Infrastructure Fund' (LIF) in Tower Hamlets.
  - Area 1 comprises the wards Weavers, Spitalfields and Banglatown, Whitechapel, St Katharine's and Wapping, Shadwell (not including a portion in the east), Stepney Green, St Peter's, Bethnal Green, St Dunstan's
  - Area 2 comprises the wards Bow West, Bow East, Mile End (not including a portion in the south), Bromley North, Bromley South
  - Area 3 comprises the wards Limehouse, Poplar, Lansbury, the southern portion of Mile End, the eastern portion of Shadwell, the northern portion of Canary Wharf, the northern portion of Blackwall and Cubitt Town
  - Area 4 comprises the wards of Island Gardens, the southern portion of Canary Wharf, the southern portion of Blackwall and Cubitt Town
