Economic well-b	 The Forum will work closely with the Roman Road Trust, a Community Interest Company of local residents and businesses promoting and developing economic well-being of the area. The Roman Road Trust has made links with almost all local businesses in the neighbourhood area and is in one-to-one conversations about their wellbeing and economic growth. During the process of making the neighbourhood plan, the Forum will devise drop-ins and workshops at the current Inter Act Hub on the Roman Road where views on local economic needs will be collected and documented to support the policies of the neighbourhood plan. 	

Environmental well- bring	London Borough of Tower Hamlets commissioned The Cass school of Architecture (London Metropolitan University) and the company Public Works to develop a public realm framework for the Roman Road and its surrounding area. This document was produced in collaboration with Roman Road Trust based on their direct testing of public locations through events and their footfall analysis. This document has clear existing environmental criteria mapped out and offers potential solutions. There are clear SWOT analyses in the document related to the physical environment of the area. There are also proposals for environmental and ecological strategies for under-utilised open spaces in the neighbourhood. There have been strategies made towards increasing wildlife habitats in current green spaces and the greening of the high street. The Forum will intend to collaborate with Tower Hamlets Cemetery to increase environmental well-being.

Community Plan and Single Equality Framework	The neighbourhood forum intend to run a series of workshops relating to the different themes of the Community Plan: - a great place to live - a fair and prosperous community - a safe and cohesive community - a healthy and supportive community These themes are a good starting point as they are broad and, we hope, will allow us to gather different views and ideas that the community may have about the neighbourhood plan area, under these headings. The Forum support the aspirations of the Council's Single Equality Framework: the neighbourhood forum steering group has already identified that we need to reach out to groups and sections of the community that may not feel that the neighbourhood plan is relevant to them. These groups could be distinguished by religion, ethnicity, age or learning/ physical disabilities. The Forum will need to try and ensure they make contact with the full spectrum of the community to ensure the emerging policies reflect the cross section of needs and aspirations for the area. The Forum steering group have already identified over 20 local groups and have made contact with many of them and met some of them face-to-face, and have further meetings organised for the coming months. Over the months ahead, as the forum expands, we intend to continue contacting these groups to explain what the neighbourhood plan is and how organisations, businesses and individuals can get involved
Core Strategy & Managing Development Document	The Tower Hamlets Core Strategy designates Roman Road as a 'district centre' (maps on p27 and p36), describes the vision for Bow (p114) and highlights Victoria Park and the Regent's Canal as significant in the borough as a whole (Core Strategy 2010-2025, Ch1 para 1.33), with the importance of connecting to open, green and water spaces highlighted as a particular challenge. This focus places added importance on the activities we carry out in ensuring the detailed knowledge of local people about the place where they live, study

and work is captured in the policies and projects proposed for the neighbourhood area. Workshops looking at the character, issues and opportunities for different places within the neighbourhood area - not just Roman Road but the various and contrasting housing estates and terraced streets, will help us to address the policy aspirations set out in the Core Strategy.

One of the activities we will need to carry out is a policy review: looking at the specific policies in the Managing Development Document (MDD) and ensuring that we aren't duplicating or contradicting these in the local plan. We will ensure that any documents such as these are available for the community to scrutinise and discuss.

We already identified in the application for Neighbourhood Area designation, that there are no Site Allocations within our proposed Neighbourhood Area. We now need to ensure we understand the policies in the development management chapter in the MDD.

The spatial diagrams in the MDD are a very useful tool for communicating policy proposals in a clear way. We would like to take a similar visual approach in our neighbourhood plan-making process to ensure that everyone who participates is able to understand and comment on the ideas for the area where physical changes are proposed.

1c. How will the Forum envisage engaging with other local forums and groups? (for example, has a Memorandum of Understanding, which could provide the basis for joint working agreements with other local forums/groups been explored?)

Local groups, including resident associations, community and religious groups and charities have been consulted, and are being kept informed of developments. A Memorandum of Understanding has been considered, but we do not believe it's needed at this point, as there is no other Forum in Bow, and we can engage with other local groups as the need arises. Please see Question 2 for how we have begun engaging with local groups in the neighbourhood area.

We are open to learn from the experience of other local Forums in the borough, and to share our learning with them through joint events. More widely, we already benefit from contact with 'My Locality' and the support, advice and guidance they provide.

2 The Forum's membership is open to everyone who lives in, works in or represents the area as an elected member.

2a. How have the Forum taken steps to promote the opportunity to be involved in the Forum and engage with local people prior to submitting this application? This may include evidence of discussions, meetings and consultations.

The Roman Road Trust, an economic and community development group, founded in 2013, initiated the Forum. It has facilitated a range of projects in Bow, including the summer Roman Road Festival, the Roman Road Yard Market and Christmas Fair. Its extensive network of contacts with local businesses community groups and individuals provided a good foundation on which to build the membership of the Forum.

A variety of means have been pursued to promote involvement and engage with local people during the past year:

<u>Public consultation meetings</u>. These started with a public meeting at St Paul's Church in February, attended by over 50 people. The neighbourhood planning process was explained, and attendees were invited to join the Forum. Following this meeting, a Neighbourhood Forum Steering Group was formed to publicise the Neighbourhood Plan process and build Forum membership. This group has met at three-week intervals to plan and coordinate the work of the Forum.

A further public meeting was held in June at Caxton Community Hall in Merchant St., in the south of the area. This focused on local community groups, and again included explanation of the Neighbourhood Plan process, including the role of the Forum, and provided opportunities for people to raise local issues of concern.

In building Forum membership, efforts continue to be made to engage as many stakeholders as possible:

Local councillors. All councillors in Bow East and West wards were contacted, and a meeting was held with Rachel Blake, Cabinet member with responsibility for strategic planning as well as Cllr Asma Begum. Cllr Josh Peck is also kept updated with progress.

<u>Community Engagement Events</u>. In collaboration with The Cass school of architecture, the steering group devised or attended a series of community events to increase Forum membership among those less likely to attend formal meetings. The events included Market Stalls, the High Street Re-imagined walk and the Mile End Community Fair:

<u>Market stalls.</u> During May and June members of the steering group held a market stall as part of the Saturday Roman Road Yard Market, on the corner of Roman Road and St Stephen's Road. This was particularly helpful in reaching people who might not belong to local groups or use the internet. This was repeated for the Christmas Fair on 3rd December, when over 40 new members joined.

<u>The High Street Re-imagined</u> was an exciting event in March 2016 where Cass architecture students took local residents on a walk in the area, talking about unforeseen public spaces and community projects that could be developed. One aim would be to increase civic pride in the neighbourhood and greater diversity of people involved in economic, cultural, and social projects. This led to debates about what projects people wanted to see in the neighbourhood, and raised awareness of the neighbourhood plan initiative.

<u>Mile End Park Community Fair</u> The Community Fair in July 2016 organised by 'Friends of Mile End Park' provided another opportunity for the Forum to consult with local people, especially over whether or not to include the park in the designated area. Strong positive views were expressed about both the park and its inclusion in the neighbourhood area, and new Forum members signed up.

The website is linked to 'Commonplace', an online public consultation platform, enabling contact with a wider group of people. This has led people to comment both on the area and any local matter of concern to them, and to join the Forum.

Flyers (translated in Bengali)

In March 2017 we printed 10,000 RRBNF leaflets. These were successfully distributed to about 80% of the circa 10,000 households in the Neighbourhood Area. Where access was refused in some estates and developments, flyers were left at reception. This is considered a very high percentage coverage that most leaflet distributers can't guarantee.

The leaflet has been translated in Bengali and the leaflet provides instructions for how the public can request a copy to be sent to them.

Letters and emails

We have sought the views of as wide a range of local individuals and groups as possible. Tower Hamlets Council for Voluntary Service provided a list of member groups in E3, which supplemented the list of local groups held by the Roman Road Trust. All the groups for which we could find contact details were contacted, and their members were invited to join the Forum. The following groups were contacted:

Ongoing consultation

We currently have **250** members of the Forum. We have sought to reach as many people in Bow as possible with the resources at our disposal, including those groups that are harder to reach. We recognise there is more work to do to increase the number and diversity of the Forum membership. We will be producing a leaflet early in 2017 providing updated information on the Neighbourhood Plan process and inviting people to join the Forum. This has been translated into Bengali.

On 24 Jan, two members of the Roman Road Bow neighbourhood forum attended a Meotra meeting. We answered the groups questions and responded to their concerns and had the opportunity to outline the timetable for the plan, inviting the group to attend a forthcoming forum committee meeting.

On 14 Feb 2017, we held a committee meeting that was open to the public. Around 10 Meotra members attended. Residents raised concerns about the role of the neighbourhood forum and that they hadn't been involved in the plan to date. Members of the forum committee were able to answer questions and assured the group that the plan was still at a formative stage and emphasised that we were keen to engage with a cross section of groups in the boundary area and that we welcomed Meotra's knowledge and experience and hoped they would help to inform emerging policies over the months ahead. Attendees left the meeting clearer about the role of the plan and forum and have invited the committee to attend the Friends of Mile End Park summer fair to publicise and engage attendees in the emerging plan.

On 25 March 2017 several members of MEOTRA attended the RRBNForum's General Meeting and we facilitated a collaborative focus group that enabled members to talk about their issues with their neighbourhood. John White, Chair of both MEOTRA and Friends of Mile End Park, agreed to act as Forum Ambassadors throughout the NP process. Notes from the focus meeting were supplied to John White for him to circulate to his group members. RRBNP explained that, while the RRBNP could and should embed the interests of smaller groups within the NP, the main aim is to create a collective vision representing the interests of all groups and working for the benefit of the whole community.

John White, their chairman, requested that the RRBNF attend their AGM to explain the process to their members.

Since then, the RRBNF has been in contact with John White on an informal basis to deepen understanding. Torange Khosari met with John White on the May 1st bank holiday weekend to discuss organising a 'NP' walk in their area to highlight and develop potential planning and development ideas.

On 31 May 2017, a General Meeting was held at the Interact Hub on Roman Road and the updated constitution was approved unanimously, enabling the Forum application to the Council to proceed, and the Council's six week consultation period to begin. All Forum members had been sent a copy of the Constitution and had been invited to attend the General Meeting via a newsletter and on social media sent out on 17 May 2017. Thirteen people attended, including representatives of local resident association John White from MEOTRA and Paul Creasy from Circle Housing. All voted unanimously to approve the Constitution. At

this meeting, several Forum Ambassadors representing different geographical areas in the neighbourhood were assigned.

The Forum will continue with informal and formal community engagement events over the year ahead.

The Forum's membership includes a minimum of 21 people, each of whom lives in, works in or represents the area as an elected member.

Local councillors Joshua Peck, Asma Begum and Rachel Blake have all confirmed strong support of the RRBNF in face-to-face meetings, however they have decided they cannot join the Forum due to conflict of interests arising from being Cabinet members.			
On 18 October Cllr Amina Ali messaged Forum member Tabitha Stapely expressing her desire to become involved but has not been in touch since despite several attempts to contact her.			
The result to date is that we have a wide representation of people who live in the area, a substantial number of members working in local businesses, and one member who is a local councillor.
